Course Description: The economics distinction program is designed to support undergraduate students who want to conduct original, high-quality research in economics. The distinction program is comprised of two courses: ECN 495 (Economic Thesis I) and ECN 496 (Economic Thesis II), which are scheduled in the fall and spring semesters, respectively. In the first course, students use economic theory and statistical principles to formulate a compelling research agenda. This includes developing an independent research question and coming up with an empirical strategy and data sources to answer this question. In the second course, students execute their research plans, present their work-in-progress, and write their theses. Students who do not complete Seminar I satisfactorily will not be given permission to enroll in Seminar II.

Prerequisites: Registration for the course is by invitation only. Students are required to complete the two-semester econometrics sequence, ECN 521 and ECN522, or its equivalent. (ECN422 is not an acceptable equivalent.) Students who have not taken these courses may take them in tandem with the economics distinction program.

Software: Empirical work will be conducted using Stata. I will provide several Stata tutorials in class and can help troubleshoot through complex tasks, but students are expected to write their own code, especially for routine tasks or more complex tasks that have already been discussed in class. To access Stata, students have three options: (1) utilize the computer lab in 030 Eggers Hall, (2) purchase a Stata license for personal use, and (3) use the virtual computers through the Maxwell School.

Office Hours: Office hours are available both in-person and virtually. You can sign up for office hour slots using the link at the top of the page. Note that you will be asked to select whether you would like to meet in-person or virtually when you book your appointment. If the scheduled Office Hours times do not work with your schedule, please feel free to email me and we can set up an alternative meeting time.

Evaluation: In Thesis Seminar I, students will be evaluated on the following criteria: economics seminars, homework assignments, weekly progress, research proposal, and research presentation. Attendance is mandatory.

• Economics Seminars (10%): The economics department hosts three economics seminars: applied microeconomics, trade and development, and econometrics

(https://answers.syr.edu/display/Maxwell/Economics+Seminar+Series). Students are required to attend at least two seminars each semester and submit a short summary of the research for each seminar. While summaries are due at the end of the semester, seminars typically take place well before the last week of classes. It is your responsibility to plan your seminar attendance in advance so that you are able to complete this assignment.

- Attendance/Participation (10%): Students are expected to attend class and arrive on time, unless there is an extenuating circumstance (illness, family emergency, job interview, etc.). Students are expected to be doing work for this course while in class. Please notify me in advance if you will be missing class.
- Homework assignments (20%): Homework will be assigned throughout the semester as needed. Homework will consist of both reading and written assignments.
- Weekly progress (20%): Progress will be assessed each week through discussion and check-ins in class.
- Research proposal (30%) and presentation (10%): Once students have committed to a research topic, students must write a research proposal and present their research proposal in class. Students will be graded on the importance, soundness, thoroughness, and feasibility of their research proposal and empirical strategy.

Feedback: I am always happy to look at your work (draft, slides, proposals, etc.) in advance and provide feedback. Please feel free to send me an email with any material you would like me to look over, and I will get back to you within 72 hours (three days). Please budget enough time for me to look over your materials in this time frame—I am unable to do last minute turnarounds!

University Attendance Policy: Attendance in classes is expected in all courses at Syracuse University.
